 - i. Attended Mansfield Borough Council yesterday, learned a lot about caterpillars
 - ii. Met with Local Assembly Exec. today, there are real opportunities for us to use LA to talk about campus climate
 - iii. He is supportive of chalking on campus, we should not be removing it, it is free speech
 - iv. He has experienced the MU family community over the past eight months, but he was proud of everyone coming together for Nova yesterday.
 - v. Continuing to work closely with the APSCUF leadership, Provost, and Gretchen, working on in-person coursework. They have nominally made progress on the fall schedule for F2F options, but they are still working on improving the schedule.
 - vi. Excited about Spring Break. Take time off to rest and recharge.
- B. Student Government Association (J. Knarr, N. Bliss):
 - i. Upcoming: Spring Fling May 1, elections- nominations April 9&16, voting April 17-30, new Exec board installed May 7
 - ii. Lower Manser is a topic of discussion
 - iii. Had requested an increase in Student Activities Fees, which did pass
- C. Admissions (J. White):
 - i. Over 200 prospective students on campus last week
 - ii. 9 transfer deposits, on track
 - iii. 97 first year deposits, hoping to hit first year goal- 130% increase in prospective students on campus so far this year over last year
 - iv. Accepted Students Day April 11- please participate to help bring in these students. 80% of students who come to this event end up paying deposit. Major Showcase Days have about a 50% yield on students enrolling.
 - v. Admissions is moving to the ground floor of Alumni for accessibility reasons- prospective students have trouble getting there and finding it on the third floor
 - vi. Did we lose a counselor? Vacancy request form has been completed to fill this position

 - i. Career Intensive Bootcamp saw growth in attendance again this year
 - ii. Big Interview platform- on-demand interview prep and practice. There is an assignments feature, so you could use this in courses
 - iii. Career Closet- as students prepare for interviews, have them take advantage of the career closet
 - 1. They currently have a great inventory, but will never say no to donations
 - iv. March 26 Professional U champions celebration, expecting 175 people at that event in Williamsport

- G. Budget (L. Sharpe):
 - i. New VP Finance, welcome!
 - ii. A number of fees are increasing for '26-27 and '27-28, driver was that fees had not been increased in a long time, and prices for everything are rising. Council of Trustees approved those Friday
- H. Campus Administrator (G. Sechrist):
 - i. Reach out if Gretchen can help
 - ii. Man of La Mancha was great
- I. Provost (M. Kiec):
 - i. Interim and Permanent Dean searches are open. Please apply or encourage your colleagues to apply.
 - ii. Concern about a minor being listed as available on MU campus but requiring a F2F course at BU
 - iii. News about the program array? Have we determined which programs will be available at which campuses? Provost said that information should have been shared by Deans, but the list is not entirely finalized yet.
 - iv. Part-time temporary faculty question, specifically in Music. Going through process of aligning number of faculty and programs offered, so they are looking at how to work with that. We are in the middle of those conversations right now. It is not the plan to limit Music majors to one campus.

IX. Discussion: Mansfield Issues

- A. Common time
 - i. **Issue:** Difficult to get people together at the same place and time; too many schedule conflicts across three campuses. Before integration, all campuses had a common meeting time during which few if any classes were scheduled
 - 1. Bloom common time was Friday 3:00-5:00
 - 2. Lock Haven common time was TuTh 12:30-2:00
 - 3. Mansfield common time was TuTh 11:30-1:00

Bloom also published a master meeting calendar at the beginning of each semester with all standing meeting times (for example, curriculum met Wed at 3, and Planning and Budget was Tu/Th at 3:30).
 - ii. **Impact:** Some reps can never make it to Local Assembly, Senate, or committee, limiting opportunities for engagement. Advantages include meeting during work hours (workday ends at 4:00 for CU staff) and enabling departments to meet; disadvantages include everyone scheduling meetings at the same time and conflicts with labs and music
 - iii. **Solutions:**
 - 1. Use MWF 8 AM or Fridays 3-5 PM, the most common times currently open. Both, however, could cause conflicts for people with kids, etc.
 - 2. Schedule courses M-Th and T-F so W is a Common Day for campus-wide events, projects, meetings, etc.
 - 3. Shift class start times to open midday times.
 - 4. Hold Lunch & Learns
 - 5. Any proposal must be run by APSCUF, AFSCME, and SCUPA
- B. Equity in academic departments

- i. **Issue:** Faculty report situations in which LA and MA are on one side of an issue and BL on the other; since BL has a numerical advantage, votes split in ways that disadvantage LH and MA.
 - ii. **Impact:** In some departments, collegiality is plummeting: there is little if any communication and consultation between faculty across campuses. This in turn adversely affects engagement and unnecessarily disadvantages campuses.
 - iii. **Solutions:**
 - 1. At the department level, votes should be decided by simple majority across campuses (two out of three) instead of number of department members.
 - 2. Management should examine department votes for fairness to all campuses.
 - 3. Improve communication across campuses. We need to talk to rather than past each other and do our best to understand the situations on other campuses. We need to think of ourselves as CU, not just one of its three campuses.
 - 4. Emulate Senate model of checks and balances, three strong voices with rotating leadership. Goal of CU is three vibrant, strong campuses; 3 identities are an asset; collegiality and civility are crucial to success.
 - 5. Rotate teaching of multimodal classes across campuses (see comments below).
 - iv. **Comments**
 - 1. N. Werner-Burke: Education has sometimes had issues in dealing with faculty at all three campuses. More than ever, it feels like the smaller schools are getting the short end of the stick. When upper-level coursework is only offered in person on one campus, majors at the other campuses dwindle. The overall institution is endangered by these kinds of lopsided course offerings.
 - 2. M. Borzok has a lot of ideas about this, she'd love to discuss this further. One of the biggest challenges is, the goals of one or two campuses are not the same goals as all three campuses. We are trying to be integrated and put forth something that is best for all of our students, but sometimes the best answer is that it's not possible across all of the campuses. The program array optimization may help, but sometimes it's not a one-size fits all solution. It may be appropriate for some issues to be solved differently on different campuses. We are serving different student populations and numbers across the three campuses.
 - 3. L. Pifer is teaching a multi-modal class, which is F2F at MU with students Zooming in from the other campuses and one from home. What if we did multi-modal and rotated who teaches the courses F2F on their campuses? A. McEvoy: you can set it up so you are teaching in-person with distance ed, synchronous or asynchronous.
- C. **Modality (F2F vs. Online for GE and major courses):**
- i. **Issue:** We have more F2F classes, but they are mainly gen ed. Upper division courses are increasingly becoming multimodal based in BL. Student government at Lock Haven has expressed concern about lack of F2F upper division courses in criminology, education, and sociology.
 - ii. **Impact:** Students may transfer or leave. Many students do not mind an online class here or there, but they don't want a lot of them, and they especially don't want most or all of their upper div classes to be online.
 - iii. **Solutions:**

1. Make clear whether faculty members should involve distance ed students in classroom activities
 2. Academic Policy Committee could consider a new policy outline expectations for online instructors
- D. Temporary faculty and program offerings:
- i. **Issue:** Cutting temporary faculty means cutting program offerings. Cutting the load of temporary faculty often causes them to leave.
 - ii. **Problem:** Inability to offer classes students need; students may transfer or leave
 - iii. **Solutions:**
 1. Losing adjunct faculty is painful, but it saves tenure-track faculty lines
 2. A. McEvoy has put in requests for 7 new faculty lines at MA to try to help the problem of not being able to offer enough in-person coursework at MA.

The EM subcommittee put forth a CU Transfer Policy this past fall, which went through first and second readings. The policy passed. We have 1 meeting scheduled for this semester, but no policies currently assigned to us.

- There is presently committee level discussion on how nimble the Senate constitution allows policy to be when policies are impacted by changes at the federal level. This is being discussed specifically in the context of the Sexual Misconduct policy, with some questioning if it makes sense to pull it out of the shared governance process entirely in order to more quickly make the necessary changes every time federal policy changes. But concerns for removal from Shared Governance have also been raised.

E. Finance Committee (T. Welch)

COMMONWEALTH UNIVERSITY FINANCE COMMITTEE MEETING

February 9, 2026 – 3:00 p.m., Zoom

CALL TO ORDER – 3:00 p.m. Present: S. Gitonga, B. Hower, A. Strouse, S. Wagner, W. Keeth, E. Hawrelak, T. Welch, S. Rosewood-Boyskey, W. Keeth, B. Thorn, D. Clark, J. Bachman, S. Lee, L. Widmann; L. Sharpe; A. Feldhaus; C. Ranck; B. Minemyer; C. Hadesty

The meeting began with Hawrelak introducing new participants, including two students and the new VP of Finance, Lisa Sharpe, with Bob Thorn in an interim role. The agenda was reviewed, and the minutes from the previous meeting were approved by acclamation. Hawrelak discussed the policy review update, mentioning that Senate had identified several policies for reformulation, with Hawrelak taking responsibility for three.

Bob presented a budget update, highlighting a revised deficit of \$9.9 million and ongoing efforts to reduce costs, including workforce reductions and IT streamlining. He discussed plans for a new CPP in May and proposed fee increases for auxiliary services, which will be reviewed by the Council of Trustees in March. Hawrelak inquired about the impact of the governor's flat funding proposal, to which Bob confirmed they are preparing for flat funding in their models, with potential tuition increases if appropriations remain unchanged. Bob also addressed workforce projections, noting planned reductions until 2027-2028, with stabilization thereafter based on enrollment and other factors.

Stacy presented a financial report overview, explaining various fund categories including ENG Plant Capital, contingency reserve, and K93 funds for deferred maintenance. She detailed how DGS projects require letters of commitment when budgets fall short, and explained the \$6 million contingency reserve for emergency repairs. Stacy also discussed the status of library projects, noting

that while the initial deadline for reducing library stacks was April 2026, this timeline had been paused. She confirmed that East 2nd Street paving in Bloomsburg, originally planned for last year but delayed by UGI utility work, would now occur in summer 2023. The conversation ended with a brief discussion of DGS projects, including the planned demolition of Waller and Old Science buildings starting March 3rd, which will require temporary relocation of the loading dock to an upper campus storage barn.

Stephen provided an update on enrollment trends, noting that spring enrollment is currently at 9,874 against a goal of 9,929, with projections suggesting 9,883 by census date, putting them down 46 from the headcount target. The FTE side shows a more positive trend, with 8,732 against a projection of 8,734, trending 36 ahead. Credit hours are also ahead of projections by 741. First-year deposits are at 811 (41.6% of the 1,950 goal), transfer deposits at 65 (15.1% of the 430 goal), and new graduate deposits at 128 (21.3% of the 600 goal). Stephen explained that these numbers are generally in line with last year's performance, with the admissions office setting realistic goals to align with revenue projections.

F. Student Affairs Committee (H. Jackson)

No report

i. First Year Experience Subcommittee (L. Pifer)

The GEC and UCC recently approved changes aimed at restructuring for general education for the FYS 100 course. These changes will take effect starting in the fall semester 2026, and were instituted following Middle States and student feedback.

FYS 100 will remain a 3-credit course, and for the time being will still be capped at 50 students. The proposal process that could be an obstacle to welcoming new faculty to the course has been removed. In support of added consistency across sections, the Committee is working with CU's Instructional Technology graduate program to create more organized Brightspace modules for the course focused on each of the core components (the "how to college" bits). Faculty will have access to these modules as the backbone of their course—which can of course be added to or modified—and their disciplinary theme can be mapped onto that core.

FYE is also working with the CU Registrar to cohort students into sections of FYS 100 by College using their major selected at admission. Students will not be selecting their own FYS courses at Orientation; first-year schedules will be built by the Registrar. This practice is intended to help students get in front of faculty that are somehow connected to their major (in broad strokes). Exploratory students will be placed in sections with designated faculty.

FYE will also be able to embed a peer leader in any FYS 100 course. Students fulfilling this role have completed training and are working in a paid position. Training will be provided for faculty to support working productively with peer leaders and in gaining familiarity with the new Brightspace modules; that training is tentatively set for sometime the week of final exams.

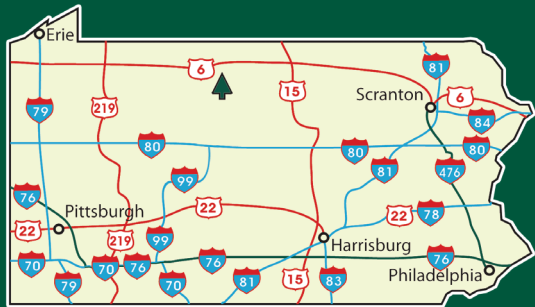
FA26 Mansfield F2F Gen Ed and Advanced Courses

Cherry Springs State Park

Cherry Springs State Park is nearly as remote and wild today as it was two centuries ago. Its dark skies make it a haven for astronomers. Named for the large stands of black cherry trees in the park, the 82-acre state park is surrounded by the 262,000-acre Susquehannock State Forest.

Recreational Opportunities

PICNICKING: Picnic tables and charcoal grills are available near the Night Sky Public Viewing Area.

HIKING: Walk the 1-mile, self-guided trail to learn how the forest of Cherry Spring State Park is an essential part of our lives.

PUBLIC PROGRAMS: On weekends in the summer, park staff or special guests may present educational programs during the afternoon or early evening. Virtual weekday programming may also be available. Contact the park office or explore the online calendar of events, <https://events.dcnr.pa.gov>, for more information on programs and other learning experiences.

WOODSMEN’S SHOW: Since 1952, the annual Woodsmen’s Show attracts thousands of spectators for the early August event. The show features lumberjack contests and chainsaw events.

History

Early Settlement

In 1818, Jonathan Edgcomb constructed a log house along the Jersey Shore Pike in Potter County. It came to be known as the Cherry Springs Tavern.

Over the years, the pine and hemlock in the Cherry Springs area was lumbered off and in their place grew hardwood trees like sugar maple and the park’s namesake, black cherry.

Civilian Conservation Corps Era

The Cherry Springs Civilian Conservation Corps (CCC) Camp, S-136-PA (1933-37), was one of ten CCC camps constructed in the Susquehannock Forest District. The men of the camp cleared underbrush, opened trails, and constructed buildings and roads.

Additionally, Camp Elliott (named for District Forester Harry Elliott) was set up at Cherry Springs. This camp was not connected with the CCC camps, but was under the supervision of the former Department of Forests and Waters. Unemployed college boys stayed at this camp, and one of their accomplishments was the construction of the 40-acre airfield at Cherry Springs (under the former State Bureau of Aeronautics) during the summer of 1935. It is now the Night Sky Public Viewing Area.

Stargazing Opportunities

There are three distinct areas for stargazing at Cherry Springs State Park -- The Night Sky Public Viewing Area, Cherry Springs Rustic Campground, and the Overnight Astronomy Observation Field. Cherry Springs can be cold and damp, even in the summer. Wear proper footgear and dress warmly. Lawn chairs, a blanket, binoculars, telescope, or astro-photography equipment may enhance your experience. All flashlights need to have a red filter. **Pets are prohibited** in all three stargazing areas.

Night Sky Public Viewing Area

On the northeast side of PA Route 44, the Night Sky Public Viewing Area accommodates casual stargazers and observers who only intend to observe for a few hours. This area is protected from light pollution using landscaping and natural plantings. Please arrive before sunset to familiarize yourself to the park. After parking in the visitor parking lot, follow the path past the information kiosk to the open viewing field.

Public stargazing programs are available on weekends late spring through early fall, weather permitting. Programs are presented by park staff or guest speakers near the amphitheater. Dark Skies

Dark Skies

Amateur astronomers realized Cherry Springs State Park had one of the darkest skies in the northeast and began stargazing in the park. Recognizing this unique resource needed to be managed and protected, in 2000, the Pennsylvania Department of Conservation and Natural Resources declared Cherry Springs State Park the first Dark Sky Park.

Due to these facts and other efforts, Cherry Springs became the second International Dark Sky Park in the world by attaining a Gold Level International Dark Sky Park certification from the International Dark Sky Association in 2008.

Cherry Springs Rustic Campground

Open early April to late October, the Cherry Springs Rustic Campground resides in a gently sloping meadow with very few trees adjacent to the Night Sky Public Viewing Area. Each of the 30 campsites include a picnic table and fire ring and use of the sanitary dump station. Visitors are welcome to campsites from 9:00 AM to 10:00 PM. Quiet hours are from 10:00 PM to 9:00 AM.

The campground often fills up during peak viewing nights, such as those on either side of the new moon phase and on nights when meteor showers are peaking. Advance reservations are recommended. Overnight Astronomy Observation Field

On the southwest side of PA Route 44 is the Overnight Astronomy Observation Field. Serious observers with telescopes, astro-photography equipment, or astro-binoculars may use this area for the full night.

A nightly fee permit is required to set up on the Overnight Astronomy Observation Field. Fee envelopes are available at the Registration Kiosk. Please follow the written instructions, posted fee schedule, and list your location on the field. After sealing the registration envelope with required fees, remove the permit with permit conditions and deposit the registration envelope in the fee deposit tube.

Electricity for charging portable power banks, telescope mounts, small appliances, or laptops is available from electric pedestals on the field. Each pedestal has six 15-amp, 120-volt, ground fault protected, power outlets. When the field is in heavy use, outlets must be shared. RV/camper hookup is prohibited.

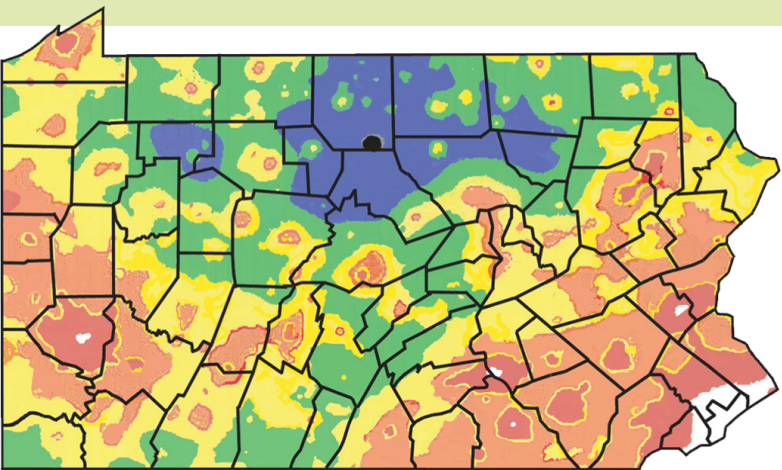
Visitors are welcome from 9:00 AM to midnight.
