Call to Order

Chair Wetzel called the meeting to order and welcomed all those in attendance. ACTION ITEMS:

Non Resident Graduate Student Technology Fee

President Hanna and Provost Kiec gave a brief overview Per BOG Policy Procedure/Standard Number 2011-02-A: *A technology tuition fee will be approved by the councils of trustees for all students; the fee must be structured in a manner that is differentiated by domicile status (in-state/out-of-state).*

Chair Wetzel made the motion to approve the Non Resident Graduate Student Technology Fee increase of \$12, making the new per credit fee \$72. Trustee Russell seconded the motion; the motion passed unanimously.

Capital Project Request FY2026-2031

Chair Wetzel introduced Ms. Suzanne Williamson, Vice President for Administration and Chief of Staff. Ms. Williamson presented the Recommended Prioritization for Funding/Authorization for FY2026 to FY2031 as follows:

1	Lock Haven – Raub Hall Renovation \$13M approved - Need additional \$5M	FY 2025-26
2	Bloomsburg – Andruss Library Renovation Expected cost \$30M	FY 2027-28
3	Lock Haven – Stevenson Library Renovation \$20M approved – Need additional \$13M	FY 2029-30
4	Mansfield – Initial Right-Sizing Request for \$20M funding	FY 2028-29
5	Mansfield – Utility Infrastructure Phase 2 \$20M approved – Need additional \$20M	FY 2029-30
6	Mansfield – Butler Renovation Expected cost \$30M	FY 2029-30
7	Bloomsburg - Centennial Renovation Expected cost \$22M	FY 2030-31

Trustee Wetzel asked for a motion to approve the Capital Project Request. A motion was made by Trustee Hanna and seconded by Trustee Zaborney; the motion passed unanimously.
