- ii. IT Subcommittee – Matthew McKeague, (Associate Professor Media & Journalism, CU) met to update the Acceptable Use Policy with minor changes.

C. Advancement Committee – Ashley Koser, (Director of Alumni Foundation, LH) commented on a great Homecoming weekend and a great win for the football team.

- D. DEI Committee – Dain TePoel, (Associate Professor, CU) working on some feedback on the Preferred Name policy and ADA policy. Looking for a SCUPA rep.
- E. Finance Committee – Stephen Gitonga, (Associate Professor MS MH Counseling LO) provided state of enrollment.

## V. Constituency Reports

- A. Student Government – Hunter Hartford, (Student Government President, LO) stated that November 6<sup>th</sup> will be Bingo. Planning end of semester bash.
- B. Alumni and Professional Engagement – Darwin Kysor, (Director Emp Engagement Career Prof Dev, LO) talked about the career expos on all campuses.
- C. Alumni Association – Philip Burlingame, (President of the Lock Haven Alumni Association) reported that the golf tournament raised over \$12k. They held the 50<sup>th</sup> anniversary for the class of 1975. Success in 90 had 55 students and 17 alumni participated.
- D. Athletics – Albert Jones, (Athletic Director, LO) stated that they won the homecoming game for football, beating West Chester for the first time in 34 years. Volleyball won against Kutztown University. Women's golf was 2<sup>nd</sup> out of 13 teams. Megan Miller awarded with all-time saves leader for soccer. Haven at the Hanger coaches show on Thursday night before every home football game.
- E. Center for Teaching and Learning – Jennifer Demchak, (Professor Environmental Sciences, CU) said that they have 8 events remaining this semester.
- F. Campus Administrator – Stephen Lee, (VP of Enrollment and Campus Administrator, LO) Thank you to President Jeff Osgood for bringing back fall graduation. All kiosks across campus have been updated with fresh paint and signage. Facilities have done a great job on cleaning the commons. Honors college is now located on the 3<sup>rd</sup> floor of Ulmer. Hunger Bowl to support the Haven Cupboard. Adopt a family will be coming out for Christmas.

- H. President – Jeff Osgood, (Interim President, CU) Participated in the golf cart parade. Lock Haven Beat West Chester. Working on next budget, around a 3.6% tuition appropriation. Restoration of allocation formula that would cover the 33% reduction. We could balance budget by 2027-28. Students advocating for less online classes. Will have more flexibility for fall. Thanks for all the participation in fall events on campus.
