Mark Decker asked if Bob could explain what the \$37 million transfer was? Bob Thorn explained that CU received a payoff for the phase 2 housing at Mansfield. That housing project totaled 37.9 million, CU received debt relief on that entire phase, that is reflected in the revenue side on the ENG side. It was an in and out transaction.

- Rylee Wenzel qualified for a pair of individual events at the 2025 NCAA Swimming Championships while the 200-freestyle relay earned an invite after posting an NCAA 'B' cut and school record time of 1:33.21 at the PSAC Championships.
- Wenzel will compete in the 100-yard freestyle and the 50-yard freestyle after winning both events at the PSAC Championships. Wenzel set the school record in the 100-free at the PSAC Championships as well with a time of 50.10.

## **Bloomsburg Athletics Fall 2024 Bullet Points**

- Bloomsburg celebrated Danny Hale's induction into the National Football Foundation College Football Hall of Fame in December. He was one of three coaches in the 2024 Induction Class and one of two people from NCAA DII. Coach Hale is the second Bloomsburg Football Husky to be enshrined in the College Football Hall of Fame, joining current head coach Frank Sheptock, who was inducted as a linebacker in 2007.
- Two members of the Bloomsburg football program, KJ Riley and Brady Thompson, were honored by the College Sports Communicators as Academic All-District honorees. The pair garnered the honors for having at least a 3.5 GPA and played in 90% of Bloomsburg's contests.
- Aydan McFarland earned first team NFHCA All-America status following up on a second team All-America honor last year. Ten (10) field hockey players earned NFHCA Academic Squad with Bella Culp, Allison Bucher, Alyxandra Flick, Lillie Weaver, and Reagan Wiest earning NFHCA Scholars of Distinction honors with at least a cumulative 3.9 GPA. Culp and Weaver are four-time honorees and Flick and Wiest have earned the award for the second-straight year.
- The men's soccer coaching staff was honored by the United Soccer Coaches as the Atlantic Region Coaching Staff of the Year and Kody Besser (First Team), Brady Rimple (First Team), and Owen Hollobaugh (Third Team) earned All-America honors. The trio of All-Americans are the first in program history from the United Soccer Coaches. Patrick Walsh and Rimple were also named All-Americans by the D2CCA. Walsh earned Academic All-American status by the College Sports Communicators.
- The Bloomsburg men's and women's swimming teams earned College Swimming and Diving Coaches Association of America (CSCAA) Fall Scholar All-America Team honors. To earn this prestigious recognition, teams were required to achieve a grade point average (GPA) above 3.0 during the Fall 2024 semester.
