2025-2025:

Delta Zeta

Dates: Reported 2/1/2025, Resolved 02/24/2025

Description: Report was submitted by a third-party student that observed several members of the organization dressed in a newspaper dress in a public area. Members were approaching students and asking them to vote. The observer noted that the individuals in the newspaper dresses seemed uncomfortable.

Findings: On 2/3/25, University staff met with the president of the organization and opened an inquiry. The inquiry found that the members of the organization were following instructions given by their advisor for a teambuilding activity. Multiple members stated feeling embarrassed and uncomfortable with the activity and were not comfortable expressing their concerns with the advisors.

Outcome: On 2/24/25, an informational letter was sent, from the Dean of Students, to the National organization and the Advisor regarding the concerns that stemmed from the activity. No other action was deemed necessary.

Zeta Tau Alpha

Dates: Charged 03/03/2020, Date Resolved 04/09/2020

Description: Violation of established initiation protocols-2 initiates were made to wear darkened sunglasses and were escorted into the location of the ceremony in a manner which deviated slightly from initiation plan.

Investigation Findings: Organization found responsible for a minor violation of the Mansfield University Student Code of Conduct section addressing hazing. The chapter leadership reported the incident to their national organization and held their own internal hearing regarding the matter, ultimately placing one of the involved members on probation pending the completion of certain sanctions, and the permanent removal of the other member.

Sanction: Given the totality of the circumstances and the minor nature of the violation, a verbal warning was issued.

Alpha Chi Rho

Dates: Reported 02/19/2025, Date Resolved July 2025

Description: Anonymous report was submitted to the Office of Student Conduct alleging "drop offs", waterboarding, inappropriate "bobbing for apples" event, and use of feces at events.

Investigation Findings: It was likely that "bobbing for apples" and "drop-offs" could have occurred. The other allegations were unfounded.

Sanction: Through a Student Conduct Conference, Alpha Chi Rho took responsibility for *disruptive conduct*. The organization was placed on Organizational Disciplinary Probation for two years.

Investigation Findings: Review of the information and interview with the student involved made it clear that no hazing was involved. Allegation was determined to be unfounded.

Alpha Theta Kappa (AOK)

Dates: Reported to Student Conduct Office 02/16/25, Date Resolved 2/16/25

Description: The Office of Student Conduct was provided the results of an investigation by the Intra-Sorority Council (ISC) regarding Alpha Theta Kappa Sorority. The ISC found the organization responsible for hazing. The charges were in regards to verbal and emotional harassment, including comments of a sexual nature, engaging in "hell week", and new members having to make embarrassing "Tik Tok" videos

Investigation Findings: The ISC found Alpha Theta Kappa responsible for hazing. Social fraternities and sororities are currently not affiliated with Commonwealth University Bloomsburg.

Sanction: Sanctions imposed by the ISC on AOK are: 4-year suspension from ISC, removal from ISC social media, no new member education for Spring 2025, no recruitment until after suspension, no social events, no ISC delegates from AOK, no ISC executive board members from AOK, notification to Commonwealth University.

Delta Pi

Dates: Incident Date 10/19/22

Description: A resident in residence life submitted a report that they suspected a fellow student was being hazed while joining Delta Pi.

Investigation Findings: University investigation did not yield enough information to support charges.

Sanction: None

Pi Lambda Phi

Dates: Reported 3/20/21, 3/31/2021, 4/30/2021, Date Resolved 5/13/21 & 7/29/2021

Description: Received anonymous reports alleging individuals associated with Pi Lambda Phi were violating university policies around hazing. Specifically, the university received anonymous reports that individuals associated with Pi Lambda Phi were committing acts of mental and emotional abuse on pledges and younger brothers, additionally forcing them to do household chores and consume alcohol underage. A follow up anonymous report alleged that pledges were being coached to deny any allegations against the chapter organization.

Sanction: Bloomsburg University terminated its fraternity and sorority life (FSL) program on 5/13/21 and severed ties with all national and local FSL organizations currently affiliated with the University. Investigation continued to determine if specific individuals were responsible but concluded on 7/29/21 there was not enough evidence to charge anyone with hazing.

Alpha Tau Omega

Dates: Reported 02/08/2021, Date Resolved 5/13/21

Description: Received a report alleging that individuals associated with Alpha Tau Omega (a disaffiliated organization) were violating university policies around safety precautions and hazing. Specifically, it is alleged that individuals associated with Alpha Tau Omega were hosting parties of over 100 individuals, many without mask and that they were committing acts of violence against individuals interested in joining the disaffiliated organization and forcing those individuals to inject bodily fluids.

Sanction: Bloomsburg University terminated its fraternity and sorority life (FSL) program on 5/13/21 and severed ties with all national and local FSL organizations currently affiliated with the University. No further recourse available.

Men's and Women's Swim Teams

Dates: Reported 10/19/2020, Investigation Initiated 4/28/2021, Date Resolved 9/27/2021

Description: Received a report alleging the men's and women's 2019–2020 swim teams were violating university policies around hazing and alcohol. Members allegedly forced to wear swimsuits across campus and participate in a "bikini and speedo party" where belongings were confiscated and alcohol consumed.

Investigation Findings: Found responsible for Alcohol Violations, not responsible for Hazing.

Sanction: Required to attend an alcohol education workshop; both teams placed on Organizational Probation through Fall 2022.

Theta Tau Omega

Dates: Incident 10/7/2020, Reported 10/9/2020, Investigation Initiated 10/22/2020, Date Resolved 12/16/2020

Description: Received two anonymous reports referencing the same date of incident. Report 1: Pledges had to regularly attend lineups where they were screamed at, blind folded, and locked in rooms. Forced to eat and drink things that they were unaware of while blindfolded like raw fish. Pledges were forced to grab poop out of a toilet. Also forced to consume a large amount of alcohol on their 'ins' night. Report 2: Locked their pledges in different rooms with blindfolds. Made them eat a bunch of things including goldfish and being told to drink others spit. Had them put their hands in the toilets to grab something out of it. The pledges had to attend lineups regularly and were forced to drink alcohol on ins night.

Investigation Findings: After exhausting the resources available, the Office of the Dean of Students has determined that the alleged violations of the Code of Conduct are unfounded.

Sanction: None

Pi Lambda Phi

Dates: Incident 10/1/2020, Reported 10/9/2020, Date Resolved: 12/3/2020

Description: Received an anonymous report stating "members were being forced to clean and are planning on feeding the pledges live goldfishes."

Investigation Findings: There is not enough information to support Code of Conduct charges.

Sanction: None

Delta Epsilon Beta

Dates: Incident 9/23/2020, Reported 10/4/2020, Investigation Initiated 10/22/2020, Date Resolved 3/22/2021

Description: Staff member received a report from a non-member of DEB about the sorority hosting parties during the pandemic and hazing of their new members.

Investigation Findings: Organization disaffiliated from the University on 3/2/2021. Nonetheless, the University held a hearing for the charges and found the organization responsible

Sanction: Delta Epsilon Beta was suspended from the University for a period of 4 years.

Delta Pi

Dates: Reported 9/16/2020, Investigation Initiated 9/21/2020, Date Resolved 12/3/2020

Description: Received an anonymous report on the hazing hotline that "forced consumption of food/drink/another substance" was being initiated by Delta Pi, investigation pending.

Investigation Findings: After exhausting the resources available, the Dean of Students Office was unable to uncover enough information to take action.

Sanction: None

Dates: Investigation Initiated 3/21/2020, Date Resolved 5/27/2020

Description: Received anonymous report stating that a social media comment made by a member could be related to body-shaming/hazing.

Investigation Findings: Not responsible. Review of post did not substantiate allegations.

Sanction: Social media education added to organization training.

Theta Tau Omega

Date: Incident 3/4/2020, Investigation Initiated 3/12/2020, Date Resolved 3/12/2020

Description: Staff member received phone call stating that they heard TTO was blindfolding members and putting them in the basement.

Investigation Findings: Contacted reporting party who said this was third hand information and could not be substantiated. Not responsible.

Sanction: None

Phi Iota Chi

Date: Incident 3/1/2020, Reported 3/3/2020, Investigation Initiated 3/4/2020

Description: Received anonymous report that new members were being made to stay at the house until late hours and did not have time for school work, and were supplied alcohol during a sorority event.

Investigation Findings: University investigation did not yield enough findings to result in charges.

Sanction: None

Kappa Delta Rho

Dates: Reported 2/27/2020, Investigation Initiated 2/28/2020

Description: A list of what appears to be mandatory, unapproved activities for organization new members was found.

Investigation Findings: Interim suspension.

Bloomsburg University terminated its fraternity and sorority life (FSL) program on 5/13/21 and severed ties with all national and local FSL organizations currently affiliated with the University. No further recourse available.

Lambda Chi Alpha

Dates: Incident 2/15/2020, Investigation Initiated 2/18/2020, Date Resolved 3/30/2020

Description: East Stroudsburg University Title IX Coordinator contacted Bloomsburg University Title IX Coordinator to inform of an ESU female student who was allegedly sexually assaulted at a party at the Lambda Chi Alpha house

Sanction: Reported to ESU and Bloomsburg town police. BU TIX Coordinator followed up with ESU and student.

Chi Theta Pi

Dates: Incident Fall 2019, Reported 1/9/2020, Investigation Initiated 2/6/2020

Description: Reported that in Fall 2019 semester, new members experienced hazing in the form of being yelled at, being put into a dark storage room, excessive memorization of unimportant information, lineups, and requirements to be at the house whenever not in class. Also reported that they were served alcohol on bids night, despite entire class being under 21 at the time.

Sanction: Organization suspended for a period of five years.

Bloomsburg University terminated its fraternity and sorority life (FSL) program on 5/13/21 and severed ties with all national and local FSL organizations currently affiliated with the University. No further recourse available.

Unknown Group

Dates: Incident Fall 2019, Reported 1/15/2020, Date Resolved 2/19/2020

Description: Members of one fraternity reported that they heard members of another fraternity yelling at new members through a wall. Reporters were not able to provide name, address, or any information about other group.

Investigation Findings: After exhausting the resources available, the Dean of Students Office was unable to uncover enough information to take action.

Sanction: None

Phi Sigma Sigma

Dates: Incident 11/11/2019, Date Resolved 11/21/2019

Description: Received information from National Headquarters via online hazing reporting form regarding an interpersonal issue between two members

Investigation Findings: Determined not to be related to any hazing activities.

Sanction: None

Mu Sigma Upsilon, Delta Sigma Theta, Phi Beta Sigma, Kappa Alpha Psi

Dates: Incident 11/6/2019, Investigation Initiated 11/7/2019, Date Resolved: 11/12/2019

Description: Received anonymous report that Mu Sigma Upsilon new members would be "earning the yard" from other organizations and would be "pledged intensely". Met with presidents of other names organizations and initiated investigation for Mu Sigma Upsilon.

Investigation Findings: Investigation did not yield information to substantiate allegations.

Sanction: None

Mu Sigma Upsilon

Dates: Incident 11/5/2019, Investigation Initiated and Resolved 11/6/2019

Description: Received anonymous report that potential new members were not sleeping at home and would come in late and leave early in the morning. No location given.

Investigation Findings: After an investigation there was no information to substantiate allegations.

Sanction: Organization was advised to adhere to all new member rules and advisor was notified.

Unknown Sorority

Dates: Incident 11/5/2019, Date Resolved 11/5/2019

Description: Received anonymous report that upstairs neighbors could hear stomping and screaming late at night, and heard some "Greeks" talking about how pledges would be "earning the yard" soon. No organization or location information

Investigation Findings: After exhausting the resources available, the Dean of Students Office was unable to uncover enough information to take action

Sanction: None

Alpha Tau Omega

Dates: Incident 10/15/2019, Charges 11/25/2019, Investigation Initiated 10/24/2019, Date Resolved 12/18/2019

Description: Received an anonymous report stating that a first semester student was in the new member process for ATO and was forced to drink alcohol at a party and then harassed for dropping out of the new member process.

Investigation Findings: Investigation conducted/completed; formal hearing conducted, organization suspended for three years. Organization recognition later revoked by Nationals.

Sanction: Organization suspended for three years

Unknown Fraternity

Dates: Incident 10/13/2019, Date Resolved 10/13/2019

Description: Received report that someone saw college students walking from a fraternity house that was playing loud music, and they looked tired and worn down. No organization or location given, only that the fraternity has a 'K'.

Investigation Findings: After exhausting the resources available, the Dean of Students Office was unable to uncover enough information to take action.

Sanction: None

Unknown Fraternity

Dates: Incident 10/12/2019, Date Resolved: 10/12/2019

Description: Received report that someone saw college students walking from a fraternity house that was playing loud music, and they looked tired and worn down. No organization or location given, only that the fraternity has a 'K'.

Investigation Findings: After exhausting the resources available, the Dean of Students Office was unable to uncover enough information provided for additional follow up.

Sanction: None

Unknown Sorority

Dates: Incident 10/11/2019, Date Resolved 10/18/2019

Description: The Office of the Dean of Students received a call from a doctor in New Jersey who had treated a female BU student. The student disclosed that she was being hazed by her sorority, including sleep deprivation and emotional abuse. The doctor was so concerned that she called the Dean's office would not disclose the student name or sorority.

Investigation Findings: Dean of Students aggressively encouraged the doctor to have the student or parent call him or utilize anonymous reporting tools as the University did not enough information to act upon. Acting Vice President for Student Affairs also contacted doctor, no further information obtained.

Sanction: None

Zeta Psi

Dates: Incident 10/10/2019, Investigation Initiated 10/7/2019, Date Resolved 10/24/2019

Description: Received a report that screaming was heard from the chapter house and people were seen walking in with hoods on their heads, followed by brothers.

Reporting party said one of the new members is a freshman, no name given.

Investigation Findings: Interim suspension on 10/9/19. Investigation did not yield information to substantiate allegations.

Sanction: Office of the Dean of Students contacted National headquarters to share information.

Kappa Sigma

Dates: Incident 10/9/2019, Already under investigation, Date Resolved 1/27/2020

Description: Received a report from a student regarding hazing allegations against Kappa Sigma. The student said he had a couple of friends joining these groups and that there is hazing and illegal pledging going on. He said his friends are not getting sleep and coming in at 5 in the morning. No time to study or get work done. He was told that they expressed they needed to study and they were told that they could not study. He said they are not doing good and are not happy. He also was told that they had to do something with vomit (he did not have any more detail about that). He also mentioned that they had to do push-ups. He said this has been going on for about 3 weeks. He would not give his name and wanted to remain anonymous.

Sanction: Interim suspension from University on 09/26/19. On suspension from Nationals effective 9/27/19. Organization recognition revoked by University and later by Nationals.

Zeta Psi

Dates: Incident 10/9/2019, Investigation Initiated 10/7/2019, Date Resolved 10/24/2019

Description: A student reported that he had friends joining this organization and they're not allowed to get enough sleep, they are at the house until early morning hours and do not have time to study. He also stated they did an unspecified activity involving vomit and have to do push-ups.

Investigation Findings: Interim suspension on 10/9/19, investigation did not yield information to substantiate allegations

Sanction: Office of the Dean of Students contacted National headquarters to share information.

Kappa Sigma

Dates: Incident 10/6/2019, Investigation Initiated 11/1/2019, Date Resolved 1/27/2020

Description: Caller left a message on the hazing hotline stating that he is concerned that freshman are being hazed and that they are returning to their rooms at 5:30AM. Considered within prior reports.

Sanction: Organization recognition revoked by University 1/27/2020 and later by National headquarters.

Zeta Psi

Dates: Incident 10/6/2019, Investigation Initiated 10/7/2019, Date Resolved 10/24/2019

Description: A message is left on the hazing hotline stating that he is concerned that freshman are being hazed and that they are returning to their rooms at 5:30AM.

Investigation Findings: Interim suspended on 10/9/19. Investigation did not yield information to substantiate allegations

Sanction: Office of the Dean of Students contacted National headquarters to share information.

ACACIA

Dates: Incident 10/6/2019, Reported 9/21/2019, Investigation Initiated 9/24/2019, Date Resolved 10/17/2019

Description: A message is left on the hazing hotline stating that he is concerned that freshman are being hazed and that they are returning to their rooms at 5:30AM.

Investigation Findings: Investigation already underway, found responsible and suspended for two years, effective immediately.

Sanction: ACACIA disaffiliated with Bloomsburg University the day prior to their formal hearing. Suspension will take effect immediately if the group returns. Interim suspended on 9/25/19.

Unknown Organization

Dates: Incident 10/2/2019, Investigation Initiated 10/23/2019, Date Resolved 10/23/2019

Description: Received report that someone overheard new members complaining about not being allowed to go home after rush activities and having to do chores. The reporting parting did not know what group they were joining but said their letters were purple and green

Investigation Findings: Identity of group unconfirmed, addressed a group that fit description to issue warning.

Sanction: Warning issued.

Zeta Psi

Dates: Incident 10/1/2019, Reported 10/16/2019, Investigation Initiated 10/7/2019, Date Resolved 10/24/2019

Description: Received report that Zeta Psi has freshman new members and they were made to drink a mix of beer, garlic and onions. They then vomited on each other, were made to roll in the vomit, and were told they would be beat up if they told anyone about this.

Investigation Findings: Organization already on interim suspension at the time of this report, investigation did not yield information to substantiate allegations.

Sanction: Office of the Dean of Students contacted National headquarters to share information.

Alpha Sigma Tau

Dates: Incident September 2019, Investigation Initiated 9/23/2019, Date Resolved 12/18/2019

Description: Received information that AST gave alcohol to underage students at a rush- related events at their house.

Investigation Findings: The University appoints a Special Investigation Team; the team investigates, and submits a final report to the University.

Sanction: Interim suspended by the University on 9/26/19 and by National headquarters on 10/3/19. Alpha Sigma Tau suspended for four years.

Pi Lambda Phi

Dates: Incident 9/30/2019, Investigation Initiated 10/3/2019, Date Resolved 10/24/2019

Description: A student reported that his roommate was pledging and was made to stay at the fraternity house until 2AM and was not allowed proper time to study.

Investigation Findings: An investigation was conducted and the group was found responsible

Sanction: Placed on probation and issued educational sanctions.

Unknown Organizations

Dates: Incident 9/30/2019, Date Resolved 10/2/2019

Description: The parent of an unknown student who rushed last semester emailed to say that their student was made to sleep at the organization's house during rush and not permitted to go back to their residence. Parent did not give name of student or organization.

Investigation Findings: No actionable information.

Sanction: None

Phi lota Chi

Date: Incident 9/27/2019, Investigation Initiated 10/3/2019, Date Resolved 10/9/2019

Description: Received a report that the sisters of Phi lota Chi locked their pledges in a bedroom of their house overnight with no access to a bathroom while they had a party. Pledges were visibly upset and in distress.

Investigation Findings: No substantiating information.

Sanction: None

Alpha Tau Omega

Date: Incident 9/24/2019, Date Resolved 10/1/2019

Description: Received photos from Snapchat showing ATO members pouring beer on a snake and allegations that there are also videos of them giving beer to a rabbit. Received via Facebook alert sent to Jamie North.

Investigation Findings: Found not responsible.

Sanction: None

ACACIA

Date: Incident 9/20/2019, Reported 9/21/2019, Investigation Initiated 9/24/2019, Date Resolved 10/17/2019

Description: Received report that Acacia is taking "underground" pledges and dropped 8 pledges off 2 hours away in their underwear. Additionally, received information from a residence life student staff member that two first semester students told the staff member they were rushing Acacia.

Investigation Findings: Initially placed on interim suspension 9/25/19. Found responsible.

Sanction: Conducted investigation, found responsible and suspended for two years, effective immediately. ACACIA disaffiliated with Bloomsburg University the day prior to their formal hearing. Suspension will take effect immediately if the group returns.

Phi Iota Chi

Dates: Date Reported 9/19/19, Initiated investigation 9/19/19, Date Resolved 9/19/1

Description: A rumor is reported alleging that Phi lota Chi is only recruiting blondes and that they are required to have intercourse with fraternity brothers. During an investigation, the reporting party states that they have no first-hand knowledge and were only spreading a rumor that they heard

Investigation Findings: Not responsible

Sanction: None

Unknown Fraternities

Dates: Date Reported 9/19/19, Initiated investigation 9/19/19, Date Resolved 9/19/19

Description: A rumor is reported that unknow fraternities are "waterboarding" potential new members and forcing them to consume alcohol, dropping them off in the woods and telling them to find their way back.

Investigation Findings: During an investigation, the reporting party states that they have no first-hand knowledge and were only spreading a rumor that they heard.

Sanction: None

Kappa Sigma

Dates: Incident Date 9/13/19, Date of Charges 12/2/19, Initiated investigation 9/23/19. Date Resolved 1/27/2020, Sanction Dates 1/27/2020

Description: A serious incident involving a student is reported, Kappa Sigma is placed on interim suspension by Bloomsburg University on 9/26/19 and by their national headquarters on 9/27/19.

Investigation Findings: The incident prompts the University to appoint a Special Investigation Team; the team investigates, and submits a final report to the University.

Sanction: A formal hearing is held and group recognition is revoked by the University. National headquarters also revokes recognition.

Description: A parent of an AST pledge or member reported that they observed an old group

Description: An anonymous submission stated that there are mandatory Monday and Thursday parties, the lowest pledge class is forced to clean, class is not considered an excuse

Investigation Findings: Responsible

Sanction: ASA is found responsible after an investigation, ASA is placed on probation and is mandated educational sanctions

Dates: Incident Date 9/13/2019, Date of Charges 12/2/19, Initiated investigation 9/23/19, Date Resolved 1/27/2020, Sanction Date 1/27/2020

Description: A student is found dead on a walking path in the town of Bloomsburg. A third- party reports that the death might be related/linked to a Rush party held by Kappa Sigma. Kappa Sigma is placed on interim suspension by Bloomsburg University on 9/26/19 and by their national headquarters on 9/27/19. The University appoints a Special Investigation Team; the team investigates, and submits a final report to the University. A formal hearing is held for Kappa Sigma.

Sanction: Organizational recognition is revoked by the University and later by National headquarters.
